Remote River Expeditions and cooperating agencies act only in the capacity of agent for all matters relating to transportation and/or all other related travel services and assume no responsibility howsoever caused for injury, loss or damage, to person or property in connection with any service, including but not limited to that resulting directly or indirectly from: acts of God, detention, annoyance, delays and expenses arising from quarantine, strikes, thefts, pilferage, force majeure, failure of any means of conveyance to arrive or depart as scheduled, civil disturbances, government restrictions or regulation, discrepancies or change in transit over which it has no control. Reasonable changes in itinerary may be made at the discretion of the trip operator. On advancement of deposit the depositor agrees to be bound by the above recited terms and conditions. Prices subject to change without notice due to currency fluctuations and/or other causes.

### **DELAYS**

**Please note:** If any trip has to be delayed because of bad weather, road conditions, flight delays, sickness or other contingencies for which Remote River Expeditions or it's agents can make no provision, the cost of delays is additional and will be collected by the trip leader.

### **CANCELLATION**

If you must cancel your trip, your deposit and all payments will be refunded, less a cancellation fee. If written notice of cancellation is received in our office between 60 and 45 days prior to departure, the fee per person per trip is \$800.00. If notice is received between 45 and 30 days prior to departure the fee per person is 60% of trip cost. If notice is received less than 30 days prior to departure the fee per person is 100% of trip cost. Trip "no-shows" will receive no refund. No partial refunds or credits will be given for unused services. Vacation cancellation insurance is recommended. Transfers: If you decide to transfer from one Remote River Expeditions trip to another, a \$50 transfer fee will be applied. If transfer occurs within 90 days of trip departure, normal cancellation fees will apply. Trip Cancellation: Although a supplementary charge can be paid to operate a trip below our minimum participant level, Remote River Expeditions reserves the right to cancel any trip due to insufficient sign-ups. In the event of cancellation a full refund of payments on land costs will be given. Remote River Expeditions and participating outfitters are not responsible for any expenses incurred by trip members such as equipment, medical costs, air tickets, etc. Insurance: We strongly recommend you protect yourself and your baggage with a short term traveler's insurance policy. Baggage is carried entirely at owner's risk; Remote River Expeditions assumes no liability whatsoever for damage, loss or delay of property. Trip cancellation insurance will cover your losses on nonrefundable air and land costs on trips cancelled due to illness.

### **RELEASE OF LIABILITY AND ASSUMPTION OF THE RISK**

In consideration of being accepted for the adventure vacation that I am participating in under the auspices of GARY LEMMER, DBA Remote River Expeditions, his agents, associates, employees, and successors in interest (hereafter GARY LEMMER) I hereby agree as follows: I have been informed and am aware that adventure travel can be dangerous and includes certain risks and dangers, including, but not limited to, the hazards of traveling by raft, by vehicle, on foot or by other means, accident or illness in remote places without medical facilities, dangers of wild animals, forces of nature, and travel by air or other conveyance, extreme weather conditions, physical exertion for which I may not be prepared, and evacuation difficulties should I be injured or disabled, I accept the inherent risks of the proposed trip and acknowledge that the enjoyment of adventuring beyond normal safety of home and work is in part the reason for my participation in this trip.

I HEREBY RELEASE, WAIVE, INDEMNIFY and AGREE NOT TO SUE GARY LEMMER for all or any liability to the undersigned, his/her personal representatives, heirs, assigns, and next of kin, for any and all losses, damages or injuries or any claim or demand on account of injury to the person or property of the undersigned, or on account of death resulting from any cause, including negligence of Gary Lemmer or others, while the undersigned is participating in this trip. I further agree that I will assume the risk of and release Gary Lemmer of all liability for any injury or damage to my body or property of my death due to any negligent failure to obtain or administer appropriate rescue operations in the event of injury, mishap, including failure to obtain adequate medical services, to evacuate or supply treatment, medicine, or trained rescue personnel. I AGREE that if I am injured or become ill, Gary Lemmer may, at my cost, arrange or supply medical treatment, evacuation or any other emergency services on my behalf as Gary Lemmer deems essential for my safety and well-being.

I EXPRESSLY ACKNOWLEDGE and AGREE that ADVENTURE TRAVEL CAN BE DANGEROUS and may involve serious and unpredictable risks of bodily injury, property damage and death, and the foregoing waiver and release is intended to be as broad and as inclusive as permitted by the law; that I am not relying on any oral or written representations of Gary Lemmer regarding safety, and that I am entering on this agreement of my own free will.
